FACTS	WHAT DOES CARVANA DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include:  • Social Security number and driver's license number • account balances and payment history • income, credit history and employment information • vehicle type and identification
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Carvana chooses to share; and whether you can limit this sharing.

Who is providing this notice?	Carvana Operations HC LLC and relevant parents, subsidiaries, and affiliates, including: Carvana, LLC; Loan Acceptance FC, LLC; Carvana FAC LLC; and Carvana Insurance Services LLC (together, "Carvana")
What we do	
How does Carvana protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Carvana collect my personal information?	<ul> <li>We collect your personal information, for example, when you</li> <li>visit our website</li> <li>apply for financing or give us your income information</li> <li>provide employment information or give us your contact information</li> <li>pay your bills</li> <li>We also collect your personal information from others, such as credit bureaus, a ffiliates, or other companies.</li> </ul>
Why can't I limit all sharing?	<ul> <li>Federal law gives you the right to limit only</li> <li>sharing for affiliates' everyday business purposes – information about your creditworthiness</li> <li>affiliates from using your information to market to you</li> <li>sharing for nonaffiliates to market to you</li> </ul> State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.
Definitions	

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.  • All Carvana affiliates, including Carvana Logistics, LLC and Carvana Shipping & Delivery LLC. Drive Time Car Sales Company, LLC ("Drive Time") and all institutions in the Drive Time family of companies, including Bridgecrest Acceptance Corporation and Bridgecrest Credit Company, LLC are our affiliates. Our other affiliates include companies with the Drive Time or DT name such as ancillary product and insurance companies including SilverRock Group, Inc., SilverRock Insurance, LLC, and Blueshore Insurance Co.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.  • Nonaffiliates we share with could include insurance companies, mortgage companies, credit card companies, and direct marketing companies.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  • Our joint marketing partners could include insurance companies, automobile dealers, and credit card companies.

### Other important information:

**California residents:** We will not share personal information with nonaffiliates to market to you, except with your express consent. We will limit sharing among our affiliates and joint marketing to the extent required by California law. CA residents are provided a CA notice for additional choices.

**Vermont residents:** We will not disclose information about your creditworthiness to our affiliates and will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures.
